## Notice of Public Hearing

Pursuant to Section 606 of the Municipal Government Act, RSA 2000 as amended, this is to advise that the Council of the Municipal District of Spirit River No. 133 has given First Reading to Bylaw No. 02-11 being an amendment to the Land Use Bylaw.

The purpose of this Land Use Bylaw amendment is to rezone a 7.4 ha (18.3 ac) portion of SE 33-79-4-W6M from Agriculture General (A) District to Country Residential (CR1) District. The purpose of the amendment is to facilitate the subdivision of a second parcel from SE 33-79-4-W6M for country residential use.

Copies of the draft Land Use Bylaw amendment are available for public inspection at the Municipal District Office in Spirit River during normal business hours as well as on the County's website at [www.mdspiritriver.ab.ca](http://www.mdspiritriver.ab.ca).

A Public Hearing for this bylaw will be held in Council Chambers on April 7, 2011 at 11:00 am. Any person wishing to appear before Council may attend the hearing and their submissions will be heard. Written submissions may be submitted to the MD's office prior to the hearing.

**The Council of the Municipal District of Spirit River No.133 will on an annual basis consider providing grants to organizations for the enhancement or upgrade of cemeteries located within the Municipal boundaries.
