NOTICE OF PUBLIC HEARING BORROWING BYLAW

Pursuant to Section 606 of the Municipal Government Act, RSA 2000 as amended, this is to advise that the Council of the Municipal District of Spirit River has given First Reading to Bylaw No. 05-2011, being a Borrowing Bylaw for the purpose of purchasing land and equipment for gravel extraction.

The purpose of this hearing is to review the bylaw which would allow the municipality to apply to the Alberta Capital Finance Authority for financing the purchase of land and equipment for gravel extraction.
